<b>General Infraction</b>	Citation for parking: <ul style="list-style-type: none"> <li>➤ In an unauthorized area</li> <li>➤ In faculty/administrative parking without a valid permit</li> <li>➤ In a safety/visitor zone</li> <li>➤ Without a valid permit</li> <li>➤ Improperly (i.e., not in a designated space)</li> <li>➤ Against flow of traffic</li> <li>➤ Other – as described on citation</li> </ul>	\$30.00**
<b>Research Fee</b>	Unregistered vehicle research fee. Fee is in addition to original infraction fine; assessed if CCS must contact the Department of Licensing for vehicle owner information.	\$20.00
<b>Disabled Parking</b>	Parking without a valid disabled parking permit	\$250.00
<b>Traffic Fine</b>	Moving Violation (Tier One)	\$40.00
<b>Traffic Fine</b>	Moving Violation with Disregard for Safety (Tier Two)	\$80.00
<b>Traffic Fine</b>	Moving Violation, Willful & Wanton Disregard for Safety (Tier Three)	\$80.00

**Notes:**

1. Parking permits are available for purchase from the campus cashiers' offices. Parking permits are subject to State of Washington retail sales tax. [RCW 82.04.050(3d)]
2. A vehicle must be registered to purchase an annual or quarterly CCS parking permit.
  - a. A vehicle license plate number is required for registration.
  - b. Parking permits are not transferable to other individuals but may be transferred to another vehicle owned and operated by the purchaser of the permit.
3. Daily permits are available from the campus cashier's office, bookstore or parking lot kiosk. Guests and visitors are given a reasonable time to secure a daily permit.
4. Parking permits are the property of CCS and may be recalled by the appropriate vice president or designee for any of the following reasons:
  - a. When the purpose for which the permit was issued changes or no longer exists; or
  - b. When a permit is used for an unregistered vehicle or by an unauthorized individual; or
  - c. Falsification on a parking permit application; or
  - d. Continued violations of parking regulations; or
  - e. Counterfeiting or altering a parking permit.
