**State Funding Support (\*9)**

In FY 2012-13, full-time equivalent students attending community and technical colleges contributed an average of \$3,217 in operating fee revenue toward instructional costs. The state of Washington contributed an average of \$3,065 from taxes and other revenues toward the total cost of instruction, which averaged \$6,282 per year for a full-time credit load.

**Notes**

For FY2013-14, the legislature authorized no increase in building or operating fees but permitted increases of student services and activities fees within established maximums. The CCS student government requested and the CCS Board approved an increase of S & A Fees which increased total tuition by \$0.69 per credit, or about six-tenths of one percent.

\*1 Washington residency established (FPS 01)

\*2 Residency status is waived for refugee (FPS 23), congressional dependents (FPS 52), high school residency (FPS 20), international student exchange (FPS 38), and higher education employees (half-time or more) and their spouses and dependents living in Washington State (FPS 24). Resident tuition applies.

\*3 Non-resident U.S. Citizen or "permanent resident" status. Idaho reciprocity included (FPS 29).

\*4 Eligible Veterans or National Guard members as defined in 28B.15.621 - 20% Waiver (FPS 70)

\*5 Other Military or Naval Veterans not qualified as "eligible" as defined in \*4 above - 20% Waiver (FPS 71)

\*6 Non-U.S. Citizen, Washington or other U.S. address or International Student (FPS 02)

\*7 State support and contract classes have a .3 Credit Minimum.

\*8 Students registered in professional/technical programs which require more than 18 credits per quarter pay a discounted rate for 19 credits and more. For students with declared majors leading to an AAS degree, all credits above 18 are considered to be required courses in professional preparation and are eligible for the over-18-credit vocational waiver.

**Notes**

- (a) In 2010, EHB 2519 made this waiver mandatory and extended it to spouses. The bill's text specifies that it applies to officers of public agencies and volunteer/full-time firefighters "in this state".
- (b) CCS administrative procedure 5.05.05-B, Basic Skills Waiver, applies. CCS Basic Skills Wavier = FPS 32 (W32). Budget Authority = \$2,000 (defined as "3% of the estimated tuition from Basic Skills;" FY13-14 estimated tuition is \$40,000).
- (c) 28B.15.740(1) Waivers for resident financially needy: CCS budgeted \$803,000 for waivers.
- (d) The FY2013-14 budget bill 3ESSB 5034 limits reimbursement for Running Start students to a total of 1.2 FTEs between their high school and college. Students will be charged tuition for unreimbursed credits or more than 15 credits.
- (e) Eligible veterans or National Guard Members are defined as:  
 "... a Washington domiciliary who was an active or reserve member of the United States military or naval forces, or a national guard member called to active duty, who served in active federal service, under either Title 10 or Title 32 of the United States Code, in a war or conflict fought on foreign soil or in international waters, or in another location in support of those serving on foreign soil or in international waters and if discharged from service, has received an honorable discharge." RCW 28B.15.621(8)(a)

Veterans "not qualified as eligible" are defined as:

"... a military or naval veteran who is a Washington domiciliary, but who did not serve on foreign soil or in international waters or in another location in support of those serving on foreign soil or in international waters and who does not qualify as an eligible veteran or national guard member under subsection (8) of this section." RCW 28B.15.621(3)
